## Patents

### The Sino-Russia PPH Pilot Project will be extended

As jointly decided by the CNIPA (the China Intellectual Property Administration) and the Rospatent (the Federal Service for Intellectual Property (of the Russian Federation)), the Sino-Russia PPH Pilot Program will be extended indefinitely from July 1, 2023 and on. All requirements and procedures involved in this pilot project will continue to apply the Sino-Russia PPH Guidelines.

PPH stands for Patent Prosecution Highway between different countries and/or regions and aims to expedite the patent examination process through work sharing between the different patent offices. Since the establishment of the first PPH program in November 2011, the CNIPA has launched PPH cooperation with patent offices in 31 countries or regions.

### CNIPA releases the White Paper on IPR Protection in China (2022)

Recently, the CNIPA released the *White Paper on IPR Protection in China (2022)* (the “White Paper”). According to the *White Paper*, in the year 2022 the overall registration of various IP rights kept on rising, with the quality and efficiency of IP rights review and examination being steadily improved. Among these IP rights, the governance on the order of patent prosecution and trademark registration has achieved remarkable progress and provided powerful support for optimizing the business environment.



## 3. Geographical Indications

In 2022 the CNIPA approved 5 new geographical indication products and 514 geographical indications to be registered as collective marks or certification marks. The CNIPA also approved 6,373 market entities to use the special mark for geographical indications. As of the end of 2022, the CNIPA has approved a cumulative total of 2,495 geographical indication products, and a cumulative total of 7,076 geographical indications to be registered as collective marks or certification marks. A total of 23,484 market entities have been cumulatively approved to use the special mark for geographical indications.

## CNIPA releases Key IP5 Statistical Indicators 2022





## Intellectual Property

### The State Council Information Office Hosts an Intellectual Property Work Press Conference and Releases Major Statistical Data in the First Half of 2023

On July 18, the State Council Information Office hosted a press conference on IP work in the first half of 2023. The relevant principal introduced the general conditions of IP work during the said period and answered questions from journalists. At the press conference, the CNIPA's Deputy Director, Mr. Wenhui Hu, released the following major statistical data:

#### 1. Patents

Besides, in the first half of 2023, the CNIPA accepted 35,000 PCT applications. A total of 33,000 patent reexamination cases and 4,433 patent invalidation cases were concluded. Also, a total of 957 international applications for industrial design were submitted through the Hague System by Chinese applicants.

### 3. Geographical Indications

In the first half of 2023, 3 geographical indication products were approved, and 97 geographical indications were approved to be registered as collective marks or certification marks. Also, 3,509 market participants were approved to use the special mark for geographical indications.

As of the end of June, an aggregate of 2,498 geographical indication products have been approved, and 7,173 geographical indications have been approved to be registered as collective marks or certification marks. Also, over 25,000 market participants have been approved to use the special mark for geographical indications.

### 4. Layout Designs of Integrated Circuits

In the first half of 2023, a total of 4,861 certificates were issued for layout designs of integrated circuits in China.

As of June 30, an aggregate of 66,000 certificates were issued for layout designs of integrated circuits in China.

### 5. Protection for IP Rights

In the first half of 2023, IP administrations at all levels across China handled a total of 21,000 administrative cases involving patent infringement disputes, and guided IP dispute mediation organizations to accept 50,000 mediation cases. Also, the construction of the first-batch 10 National Intellectual Property Protection Demonstrative Zones was launched during this period.
